2. Minutes of previous AGM

3. Chairpersons' report (Keith Gove and Vicki Clark)

It has been a challenging year - with Erin on maternity leave - but we are extremely lucky to have Deb Chapman as acting Statewide Coordinator. RecVic has continued to maintain strong connection with the network of Local Reconciliation Groups (LRG); we continued and built on engagement with the Constitutional Recognition campaign led by Emily Chauvel Byrne; continued working closely with other orgs – e.g. VLGA on HART awards, City of Melbourne, Reconciliation Australia, and ANTaR Victoria. Small organisations like RecVic have to work in partnership.

Council is strong and stable; no election is required this year. We are in strong financial position although we operate on few resources. Keith acknowledged the commitment and support from State Government. We are in conversation with the Government and Opposition about continuation of funding beyond June 2015.

RecVic has continued to work in local government space – we hope to see Maggolee local government website launched next year – and State Government has confirmed its intention to see this happen. We are commencing to explore opportunities for work in schools space. We are gradually building awareness in the community about Constitutional Recognition of Aboriginal and Torres Strait Islander Peoples in the Constitution.

Staff are fully committed, and the energy they bring to our work and to Council keeps the organisation vibrant. For such a small team they are very effective. Deb Chapman has become a great sounding board, and personally supportive. Emily Chauvel Byrne has been all around the state – listening to all sides of the Constitutional Recognition discussion – we thank her for bringing thousands of conversations back to the Council.

Thanks to our volunteers – for work on stalls, etc. and to ANTaR Victoria for such a strong relationship. Our Council members are very committed; they take on extra responsibilities, and are active in sub-committees.

4. Financial Report and Statement – John Farlow (Treasurer)

Though we produced a deficit of approx. \$60K, we still have healthy reserves to draw on to run events. Major contribution to the size of the deficit was a large one-off expense: the Maggolee website.

Looking to the future: we have \$85k in bank – more than enough to continue til the next funding tranche.

5. Statewide Coordinator's report – Deb Chapman

"I'd like to first take time to think of the land we are on and what it has been like for Aboriginal people".

It has been a busy year: e.g. NRW – at least 120 events. It's a privilege to work with the LRGs and to see bottom-up change at the grassroots level. This is a vibrant and important space, and RecVic is in demand around community.

Hardest job ever, but the most satisfying – we work with great people.

It has been a great year of consolidation. We work in a contested space which requires constant and careful negotiation. I appreciate the wisdom and commitment of our Council, and it's a delight working with the team – we bring complementary skills.

We have reactivated our work on 'treaties and agreement making', and will be inviting the Aboriginal community to an event in near future to hear from them what they see as our place in that discussion.
